



## Inspection & Consumer Services Custom Meat Processor Program

We hope you will find this list of current Colorado meat processors helpful. Facilities are listed alphabetically by name. Please refer to this legend for further clarification.

- **“USDA Official = Yes”**: Meat intended for sale must be slaughtered & processed under USDA inspection. Firm may also process custom livestock and/or wild game for the owner’s consumption.
- **“Processor = True”**: Firm is allowed to custom process livestock and/or wild game for the owner’s consumption only. Meat from these firms may not be sold.
- **“WG = Yes”**: Firm is licensed to process only wild game for the owner’s consumption. Firm may not process livestock.
- **“Mobile = Yes”**: Firm has a mobile slaughter unit, and may only slaughter livestock for the owner. Firm may not further process or package meat.
