**35-80-108 Unlawful acts.** (1) Unless otherwise authorized by law, it is unlawful and a violation of this article for any person or entity: (i) To import or have in such person's possession for the purpose of selling, trading, giving, or otherwise transferring certain species of birds designated by the commissioner (psittacine birds) that have not been legally banded with a leg band applied during the prefeathered stage of development and appropriate to the size and species of the bird
