FEE SCHEDULE**

**INSPECTION FEES**

**CATTLE**

\$20.00 minimum fee - per stop (country cattle)  
\$15.00 minimum fee - per stop  
(all cattle going direct to slaughter from feedlot)  
\$.65 per head inspection fee (country and sale)  
\$.63 per head - fat cattle to slaughter  
\$.60 per head - fat cattle (over 500 head)  
\$20.00 per head - show cattle travel permit  
\$3.00 per head rodeo cattle travel permit  
\$.52 per mile - no brand calf mileage

**HORSES**

\$35.00 minimum fee - per owner  
\$2.00 per head inspection fee (country)  
\$3.00 per head inspection fee (public livestock market)  
\$35.00 per head - travel permit

**SHEEP**

\$15.00 minimum fee - per stop  
\$.40 per head inspection fee (upon request)

**CERTIFIED FEEDLOT PROGRAM**

\$1,000.00 per feedlot - good for one year (July 1st - June 30th)  
\$.48 per head - cattle leaving certified feedlot going directly to USDA slaughter plant

**PROMOTION FEES COLLECTED FOR COLORADO BEEF COUNCIL AND  
COLORADO HORSE DEVELOPMENT AUTHORITY**

**CATTLE**

\$1.00 per head - beef council fee

**HORSES**

\$3.00 per head - horse promotion  
\$100.00 maximum charge per person per year

**HIDE INSPECTION FEES**

\$.25 per head inspection fee  
no charge for hide releases

**DAIRY/FEEDLOT CALF PERMIT**

\$50.00 per application - good for one calendar year

**FEE WAIVER**

\$100.00 per application (good for period of two calendar years)  
\$20.00 minimum fee - per stop (collected upon inspection of livestock)

**BRAND RECORDING AND ASSESSMENT FEES**

\$200.00 research fee - new brands or reinstatements  
New brand assessment fee is \$180.00 - will pay the brand through December 31, 2021  
  
\$100.00 transfer fee per brand  
\$100.00 fee per brand for lease agreements - leases valid through December 31, 2021  
\$1.00 fee - certified copy of brand deed  
2017 assessment fee \$300.00 plus applicable late fees – five year period through December 31, 2021  
\$30.00 each - 1997, 2007 and 2017 Brand Books

**LOST INSPECTION DOCUMENTS**

\$40.00 per hour research fee for duplicate inspection certificates

**ALTERNATIVE LIVESTOCK FEES**

\$300.00 maximum license fee - one year September through August  
\$15.00 minimum fee - per owner  
\$5.00 per head inspection fee  
\$1.00 per head inspection fee at alternative livestock sales  
\$10.00 per head - travel permit - good one year from date of issue

**SALE BARN FEES**

\$200.00 license for sale barns - one year period May 1st to April 30th

**ESTRAY FEES**

\$20.00 advertising fee  
\$.49 per mile - investigation and transportation

**LAW BOOK**

\$10.00 per book for the Colorado livestock statutes booklet
